



Compliance Monitoring 101: Practical Tools, Tips, and Strategies for New and Experienced Compliance Monitors

The primary purpose of compliance monitoring within the context of the Juvenile Justice and Delinquency Prevention Act (JJDPA) is to ensure that states and localities are effectively implementing and adhering to the Act's core requirements. This session explores how states may use the 8 elements of an effective compliance monitoring system to fulfill the core requirements of the JJDPA. Participants will gain tools to build or enhance monitoring systems.

Rise To The Challenge! Creating Public Safety With Healing, Accountability And Positive Relationships.

RISE-Up House is California's first Less Restrictive Program (LRP), designed for justice-involved young adults ages 18–25 to serve the remainder of their confinement in a community-based, healing-centered environment. It's more than housing—it's where structure meets support, and personal accountability is met with radical empathy. Every day at RISE-Up is built around emotional growth, life skills, and repairing community bonds.

Co-Creators of Change: Partnering with System-Impacted Youth to Transform Policy Through Story, School, and Strategy

What happens when youth aren't just heard—but lead? This workshop showcases a powerful, community-based model where system-impacted youth and families become co-creators of change through storytelling, school, and entrepreneurship. From publishing books to launching businesses, young people shape real solutions to injustice. Come learn how to shift power, build trust, and partner with youth to create bold, lasting reform from the inside out.

Stories + Data = Change: Youth Shifting Narratives and Building Power
Good Trouble's Youth-Powered Justice workshop will share how youth at the margins can lead change as storytellers, researchers and policy co-creators. Led by two young leaders of Minnesota's Good Trouble movement who've faced justice-system experience, school failure and poverty, participants will experience our youth-led feedback process—combining lived experience, storytelling and data—to shift narratives and redesign schools. This interactive session offers concrete tools for meaningful youth-adult partnerships and replicable practices for community-driven system redesign.

Concurrent Workshop Session #2 Wednesday 2:00 pm - 3:15 pm

Authentic Engagement: Turning Youth Storytelling into System Solutions

This workshop will focus on the power of youth storytelling to inspire and drive real systemic change. Through authentic engagement and lived experiences, participants will explore how youth voices can not only highlight challenges but also spark innovative solutions within the justice system and beyond. The session will delve into three key subtopics that demonstrate how youth-led narratives can create ripples of transformation: gender-responsive programming, community-based alternatives to incarceration, and youth-led accountability and policy design.

We Can Solve This: Community-Led Youth Justice Transformation in Kent County, MI Grand Rapids, Michigan is reshaping youth justice through a countywide cross-sector initiative. Grounded in data, community leaders co-developed a Community Plan including shared measurement, a Youth Justice Continuum, and Policy Recommendations. The work prioritizes systems-level alignment among key sectors - education, courts, and community-based programs - to address early risk factors, support youth and families in navigating the system, and align policy and funding. This session shares lessons, tools for systems mapping, and strategies for collective action.

INVITE ONLY - Youth Reentry Roadmap App Session - Center for Improving Youth Justice

The Center for Improving Youth Justice (CIYJ) invites participants to a collaborative and interactive session focused on outreach strategies for engaging young people transitioning from secure placement back to the community. As part of a national pilot, CIYJ is testing the Reentry Roadmap—a mobile app designed to support youth in navigating reentry through personalized guidance on housing, health, education, employment, and community involvement. Despite promising features and incentives, recruiting youth participants has proven challenging. This session will explore barriers to engagement, share lessons learned from the pilot, and invite attendees to co-create solutions for reaching and retaining young people at this critical reentry phase.

How to be an Effective Team when Implementing Evidence-Based Programming for Youth This session will focus on preventing team dysfunctions as the team implements evidence-based programs. The discussion will center around techniques the team can use avoid being ineffective in producing results.

Concurrent Workshop Session #3 Wednesday 3:30 pm - 4:45 pm

- From Punishment to Prevention: Better Approaches to Addressing Youth Gun Possession While rates of gun possession are not increasing nationwide, more and more youth especially Black youth are being arrested, prosecuted and harshly punished for simple gun possession. These punitive responses damage young people's futures and harm public safety. The workshop will detail the research on youth gun possession and describe a successful diversionary program for youth accused of gun possession and gun violence intervention models working with youth and young adults at highest risk.
- Real Stories, Real Outcomes. Advancing Change Through Storytelling
 The combination of data and storytelling empowers change. This is particularly true in our
 digital world where news of negative outcomes disproportionately pushes fear and
 hopelessness. Learn how to empower staff and young people to work together to tell positive
 outcomes stories that advance scaling of effective program models.
- From Voices to Futures: Youth-Driven Education
 This session presents an evidence-based, clinically driven approach to gathering feedback from youth to identify educational programming that is meaningful, relevant, and socially valid.
 Attendees will learn how to design and implement open-ended surveys and focus groups to engage youth, generate actionable data, and inform programming that enhances motivation, increases participation, and potentially supports long-term outcomes.
- A Conversation on Doing our Work: Advancing JJDPA RED Compliance
 The Juvenile Justice and Delinquency Prevention Act (JJDPA) requires states to identify and reduce racial and ethnic disparities (RED) as a core component of youth justice reform. This session will provide RED Coordinators, state advisory groups, and youth justice leaders with practical insights, guidance, and examples of what meaningful compliance with the fourth core requirement looks like in action. To ensure the discussion meets the real-time needs of the field, we will poll national RED Coordinators in advance to gather the questions, concerns, and guidance they most need to do their work. The session will be tailored in response to those requests, creating space for a dynamic, solutions-focused dialogue.

Panelists will discuss the intent of the JJDPA and the responsibilities of states to not only collect data but to develop and implement actionable strategies that move beyond compliance toward systemic change. Participants will explore pressing questions, including: What clarifications and technical assistance are most needed at this time? What barriers continue to challenge states in addressing RED? What guidance and tools can help states align their efforts with the spirit of the JJDPA? Through a facilitated dialogue, attendees will gain a clearer understanding of current federal expectations, learn about innovative practices, and leave with actionable strategies to strengthen their state's RED efforts.

Concurrent Workshop Session #4 Thursday 10:15 am - 11:30am

"Bridge Builders" - Advancing Youth Restorative Justice Circles and Practices to improve Police-Youth Relations

This workshop explores how restorative justice (RJ) practices are used to improve police-youth relations in the District of Columbia and Maryland, with a focus on the impactful work of nonprofits like the National Center for Children and Families (NCCF). Participants will learn how RJ—through initiatives such as youth advisory councils, community events, and therapeutic art and self-expression—can foster mutual understanding, reduce racial disparities, and promote healing and accountability between law enforcement and youth.

- Putting Students First: Creating a District Guide for School Resource Officer Contracts
 Solutions Not Suspensions has spent the past year developing a district contract guide for
 School Resource Officers grounded in community input and student-centered values. This
 workshop will share our methodology, highlight the current state of SROs in Minnesota, and
 explore how districts can create transparent, equitable agreements. Participants will engage in
 discussion and leave with tools to strengthen accountability and support positive school
 climates.
- NextWave Leadership: Investing in Justice-Involved Youth as Changemakers
 The NextWave Leadership Program invests in youth ages 18-25 who have been impacted by the criminal legal system as powerful changemakers, addressing systemic barriers to leadership, economic mobility, and civic engagement. Through financial investment, mentorship, and capacity building, NextWave equips young leaders with tools to drive systemic reform. This workshop shares the program's youth-driven model, real-world successes, and strategies for integrating lived expertise into policy and practice. Participants will gain practical tools to create sustainable, equity-driven leadership pathways within their organizations and communities.

State Advisory Group Free-Form Networking Session

This is a free-form networking space for SAGs and DSA staff to collaborate and brainstorm solutions to state-specific issues.

- Money Talks: Investing in Youth-informed and Justice-informed Financial Literacy Education
 Our workshop invites participants to create youth and justice-informed financial literacy
 solutions, which are crucial for overcoming racial and economic disparities. Through storytelling
 and hands-on small group activities, attendees will identify the financial literacy education
 needs of justice-involved youth. Participants will leave the workshop feeling motivated to
 center youth voices in the co-creation of financial literacy programming. BeRe co-facilitators
 will share insights from their own experience of creating a youth-informed and justiceinformed financial literacy program.
- These are Our Kids: New Tools and Strategies to Engage Youth, Families, and Communities to Advocate for Youth in Custody

This interactive panel brings together a community advocate, a facility administrator, and youth justice experts to explore new tools for transparency and accountability in youth detention. Participants will see how families and communities can use JJAI's updated Youth Facility Conditions Assessment and web-based app to shine light on conditions inside facilities, promote youth wellbeing, and partner with system leaders to drive meaningful reform.

- Strength Over Struggle: Lived Expertise as Data for Youth Justice Reform

 This workshop draws on new data from The Sentencing Project showing that racial and ethnic disparities in the youth justice system are worsening nationwide. Together, the presenters will guide will participants through strategies to bridge the gap between data and lived reality, build authentic community trust, ensure equitable funding for grassroots organizations, and center youth and family voices in state and national policy.
- Centering Youth Voices Today for Sustainable Solutions Tomorrow Please Don't Give Up on Us: Stories from Incarcerated Youth and Children in California

The youth of our state are its greatest assets, yet the justice system they encounter often fails to fully recognize and support their potential. This report represents a collective vision for not just reimagining juvenile justice but recreating one that is rooted in accountability, fairness, and opportunity. Endorsed by the OYCR Youth Advisory Board, this report reflects the voices of young people who have directly experienced the system. Their insights and lived experiences provide a powerful lens for understanding both the challenges and opportunities within our current framework. Their advocacy reminds us that effective reform must be shaped in partnership with those it is meant to serve. The findings and recommendations outlined in this report are presented with the goal of building a system where all youth are met with dignity, compassion, and meaningful pathways for growth. From reducing systemic inequities to prioritizing rehabilitation over punishment, this report serves as a call-to-action for policymakers, practitioners, and community leaders alike.

COALITION FOR JUVENILE JUSTICE (CJJ) REGIONS OF STATE ADVISORY GROUPS

The composition of the JJDPA State Advisory Groups (SAGs) regions is defined in the CJJ Bylaws. Each region's members are represented on the CJJ Executive Board by a Regional Chair and 1-to-2 Regional Representatives. Memberships in CJJ are granted to all SAG members, as well as the state staff that work on JJDPA matters with the SAG (including the state Juvenile Justice Specialists, DMC Coordinators, and Compliance Monitors).

The Chair/Chair-designee of each CJJ member-SAG has a vote in all proceedings of the CJJ Council of SAGs. The Council is responsible for Bylaws, electing Officers to the Board, and approving major policy positions. The Council of SAGs shall meet at least once annually. The CJJ Executive Board convenes at least 4 times per year to act as the governing body for legal, fiscal and strategic decisions, reflecting the views of CJJ members and stakeholders.
